

# **Bishop's Committee for the Environment (BCE) Green Grants for the Genesis Covenant 2017**

## **BEFORE BEGINNING A PROJECT**

1. The Green Grant maximum is \$500.
2. The Green Grants are matching grants and so the church is expected to contribute a sum approximately equal to that requested in the grant application. Utility rebates can count as part of the church's contribution.
3. If your church is a first time applicant, be sure that your church has some of these requirements in place:
  - a. The church has a committee or person whose mission is care of Creation, environmental responsibility, or similar mission
  - b. The church has a greening plan in place (it can be a very simple list of goals, a "To Do List", or a similar document)
  - c. The church has completed an energy audit – either a self-audit or an energy audit by the local utility or has an active Portfolio Manager account
  - d. The church has checked into the rebates that might be available through its energy providers
4. If your church is a returning applicant, your church must have completed some steps before submitting a new application. Please complete page 3 of the application.
5. First time applicants are considered first for Green Grant funding.

## **PROCEDURES FOR CHURCHES**

1. Complete the application.
2. Submit the Green Grant Application by **May, 15, 2017**.
3. If the application is approved, please plan to complete the work by the end of 2017 if at all possible.
4. Please keep copies of receipts for the work and forward to the BCE (see address on application form) when work is complete.
5. Photographs of the completed work or "before" and "after" photos would be much appreciated.
6. If your application is approved, the BCE will request that the Diocese mail your church a check for the amount of the grant.

## **ACTION BY THE BCE**

1. The Application will be reviewed by the BCE Green Grant Committee and submitted to the BCE for approval.
2. Preference will be given to first time applicants and applicants with an up-to-date Portfolio Manager account.
3. The church will be informed of the BCE decision by **June 10, 2017**.

## **NEED SOME IDEAS? OTHER CHURCHES HAVE CARRIED OUT THESE PROJECTS:**

1. Replaced CFL or incandescent light bulbs with LEDs
2. Replaced old-style EXIT signs with new LED models.
3. Blown insulation into attics or walls.
4. Replaced leaky single-pane windows.
5. Installed occupancy sensors.

## **OTHER CONSIDERATIONS**

1. Green Grants are envisioned as a way for our diocese to respond to the challenge of the Genesis Covenant – to reduce energy use at all church facilities by 50% in 10 years. The Covenant was adopted by the national church at its 2009 convention. So applications that reduce energy use at the church or by the congregation get first priority.
